Conditions of participating in the proceeding Permissions to perform a determined business activity or action

In the proceeding to receive the order can participate only those Tenderers, who at the date of submitting an offer to the Awarding Entity run an active business activity that is not in the period of suspension or period of bankruptcy proceeding.

Condition meeting evaluation method: The Contractor's declaration that constitutes as an element of the offer form.

Knowledge and experience

The Contractor should possess knowledge and experience that will allow him to correctly perform the subject matter of the order. This condition is considered to be fulfilled if the Contractor submits an appropriate declaration constituting as Annex no. 1 that he possess knowledge and experience that allow him to correctly perform the subject matter of order, which is included in the contents of offer form constituting as Annex to this Announcement.

Technical potential

Economic and financial situation

In addition, the fulfilment of the condition will be verified by a signed declaration, which is a part of the offer form.

Additional conditions

- 1) In the agreement with selected Contractor will be included records in the scope of confidentiality rules, in particular: "During the execution of the subject matter of the Agreement, as well as after its cessation, the Contractor shall oblige to keep in secret all expressly indicated technical, technological, organisational, or other information that possess an economic value (Confidential Information), with which he shall familiarise or which he shall receive from the Awarding Entity in any form during and in relation to the execution of the subject matter of the Agreement with the exception of publicly known and well known information."
- 2) Only the Tenderers, who do not have interpersonal or capital relations with the Awarding Entity can participate in the proceeding to receive the order. The interpersonal or economic relations should be understood as mutual relations between the beneficiary or persons authorised to make commitments in the name of beneficiary or persons carrying out activities related to the preparation and execution of the Contractor selection procedure on the behalf of beneficiary and the Contractor, in particular consisting of:
 - a. participation in Company as a stakeholder of civil or partnership company,
 - b. possession of at least 10% of shares or stocks,
 - c. acting as a member of supervisory or management authority, proxy, or representative,
 - d. staying in a marriage, relationship or kinship in a straight line, relationship or kinship in a collateral line to the second degree, or in an adoption, care, or guardianship relationship.

Agreement change conditions

The Awarding Entity reserves the ability to change the scope of agreement concluded with entity selected as a result of conducted proceeding only in the form of a written annex due to the following reasons:

- justified changes in the scope and method of carrying out the subject matter of order,
- objective reasons not attributable to the Awarding Entity or the Contractor,
- circumstances of force majeure,

- changes of legal regulations in force at the date of signing the agreement,
- reception of decision of entity financing the project, which contains changes of the scope of tasks,
- dates of execution or determining additional provisions, to which the Awarding Entity will be obliged.

Such changes will be approved only under the condition of the Contractor submitting a written application and the Awarding Entity approving the said application and their implementation will require a written form under the pain of invalidity.

Offer price

Criterion No. 1 : NET PRICE of Mould (P1) (60% of evaluation weighting) - calculated according to formula: P1 = $(Cn / Cr) \times 60$

where:

P1 – number of points in criterion 1 granted to the reviewed Contractor for price from offer

Cn – lowest net price for a set of moulds

Cn - lowest net price for a set of moulds in the reviewed offer

70 – weight of criterion

Net price expressed in PLN is a net lump-sum price, which means that the offered price includes all necessary components covering all price positions of the Tenderer necessary to correctly carry out the subject matter of order.

Criterion No. 2 : ORDER SUBJECT MATTER EXECUTION DATE (P2) (40% of evaluation weighting) - counted as a number of calendar days from the date of submitting an offer, in which the Tenderer declares readiness to execute (i.e. deliver) the order - calculated according to formula:

 $P2 = (Dn / Dr) \times 40$

P2 – number of points in criterion 2 granted to the reviewed offer

Dn - date of the shortest offer from all offers expressed in calendar days

Dr – date of reviewed offer expressed in calendar days

30 – weight of criterion

Total evaluation of reviewed offer (P) : P = P1 + P2 Maximum number of 100 points is granted to the offer with the highest evaluation score.

B) The Awarding Entity will choose the most favourable offer on the basis of evaluation criteria of offers determined in this offer query. All offer selection criteria should be referenced in the offer.

Exclusions

From participation in receiving the order will be excluded Tenderers, who:

- a. have submitted the offer after the deadline indicated in the proceeding,
- b. have submitted the offer in an incorrect way or signed by a person, who is not authorised to represent the Tenderer,
- c. have submitted an incomplete offer or offer without required annexes,
- d. have submitted the offer on an incorrect offer form,
- e. have interpersonal or economic relations with the Awarding Entity.

Under this proceeding, the Awarding Entity does not allow the acceptance and granting the approval to submit and carry out the order in a partial or variant way to any Tenderer.
